MINUTES OF THE WALBERTON PARISH COUNCIL PLANNING COMMITTEE HELD IN THE PAVILION AT 6.30pm ON TUESDAY 1 AUGUST 2017.

344/17 Record of attendance and apologies

346/17 Confirmation of minutes

The minutes of the Planning |Committee meeting of 13 July were confirmed as a true record of the business transacted.

347/17 Public questions

No members of the public were present.

348/17 Neighbourhood Plan Steering Group

Cllr Mrs Clark reported that the public meeting held on 28 July 2017 had 150 people in attendance. The presentations on planning issues by Cllr Camerer Cuss, Mr Peter Brown and Mr Peter Youatt well received. The meeting had met its prime objective of raising local public awareness of the complexity of planning issues.

349/17 Councillor resignation

The resignation of Cllr Mrs Wallsgrove, Vice Chair, was noted. Resolved: The Clerk to send Mrs Wallsgrove a letter of thanks. Cllr Mrs Clark proposed Cllr Mrs Lewis as committee Vice Chair. Seconded by Cllr Camerer Cuss. Cllr Mrs Lewis agreed to accept the position. Resolved: Cllr Mrs Lewis elected unanimously as Vice Chair.

351/17 Planning applications

Statutory notices

1.WA/36/17/HH – Bramble Cottage, West Walberton Lane. Enlargement of 1 no dormer, addition of 1 velux rooflight on the southern elevation, the addition of 2 no dormer windows on the northern elevation & replacement windows & external doors - This application affects the character and appearance of Walberton Green Conservation Area. Comment by 17 August.

Resolved: Not to comment.

2. WA/38/17/PL – Walberton House, The Street, Walberton. Change of use of a store to a single dwelling with a porch extension & one additional window to north & west elevations & to east facing roof slope (Renewal of consent WA/6/14) This application affects the character and appearance of the Walberton Village conservation area

Resolved: To support.

3.WA/44/17/OUT- Tuppers Field. Outline application with some matters reserved for up to 175 dwellings, new vehicular access, together with associated car parking, landscaping& community facilities to include allotments, play space &community orchard. This application is a Departure from the Development Plan & may affect the character& appearance of the Walberton Village Conservation area. Comment by 10 August. To review and approve draft comment attached, accepting minor amendments.

<u>Resolved</u>: To object. Draft objection comment approved with amendments as agreed.

Non-statutory notices

1. WA/46/17/TC – 11 Maple Road, Walberton. Fell 1 No. Fig tree & 1 No. Magnolia tree within Walberton Village Conservation Area. Comment by 11 August.

Resolved: Not to comment.

2.WA/47/17/PL - 3,4 &7 Sussex Business Village, Lake Lane, Barnham. Variation of conditions 1 & 3 under WA/4/00 relating to the restrictions imposed to allow further use and development. Comment by 17 August. Resolved: Not to object.

Additional

1. EG/46/17/OUT - Land north of Spode Cottage & West of Greenings & South of Fontwell Cottages Eastergate Lane, Eastergate. Outline application with some matters reserved for up to 30 No. dwellings & two vehicular access points. This application is a Departure from the Development Plan. Comment by 17 August. Although the application is in Eastergate parish, the entrances are on Eastergate Lane and Fontwell Avenue.

<u>Resolved</u>: To object on the grounds below. The Clerk to copy in Gary Sleet, Eastergate clerk:

- 1. Insufficient evidence on several matters, including highways, environment, drainage and LVR.
- 2. Contrary to Eastergate and Barnham neighbourhood plans.
- 3. Unsatisfactory entry into and exit from A29 Fontwell Avenue.
- 4. Increased through-traffic using Walberton village.
- 5. Increased flood risk.

352/17 Planning decisions

Planning decisions relating to WA/29/17/RES – Progress Garage, Yapton Lane, Walberton, and WA/30/17/L – Manor Lodge, The Street, Walberton, were noted.

353/17 Woodfield Farm, Wandleys Lane

No update to receive.

354/17 Welbeck site (Old Dairy)

Cllr Mrs Clark reported that no application has yet been submitted and, until one is, the council is not in a position to comment.

355/17 Tuppers Field

Correspondence from Michael Eastham (ADC) regarding Sec 106 contributions and the deadline date for submission was noted. Cllr Mrs Clark gave an overview of the situation and suggestions for what contributions should be considered. She will prepare a short paper for approval by members prior to submission by the Clerk.

356/17 Ford Neighbourhood Plan Consultation

- 1. An update was received from Cllr Strickland.
- 2. A joint draft parish council and neighbourhood response was reviewed. The closing date for comments is 4 August 2017, not 2 August as previously stated.

Resolved: To agree the draft response, which will be submitted by the Clerk.

357/17 Fairmead Farm – Binsted

No update available.

358/17 Neighbourhood Plan review

Cllr Camerer Cuss reported that NP is due to be reviewed. As changes in the rules are likely to apply, he suggested that work is started as soon as possible. It might be appropriate for the \clerk to open paperwork with ADC for the area to be designated as a Statutory Body.

359/17 Highways

Cllr Camerer Cuss reported that the next JWAAC Highways & Transport Subcommittee meeting is on 17 October. The agenda shows that road featured for discussion are in the Felpham and Bognor area.

Cllr Mrs Clark reported that she had reminded people attending the public meeting on 28 July to report potholes in West Walberton Lane to WSCC, and HGV's driving through Walberton village to Op Crackdown.

360/17 Fontwell cycle path

Cllr Mrs English referred to the recent letter received from WSCC, and recommended that the council should not be seen to be opposed it. Resolved: Not to oppose the proposed cycle path in Arundel Road, Fontwell.

361/17 South Downs National Park

No update to receive. Cllr Camerer Cuss said that he would attend the next committee meeting.

362/17 Cluster Liaison Planning

Cllr Camerer Cuss had nothing to report.

363/17 Conservation issues

No issues raised.

364/17 Barnham Trojans goal store

The Clerk updated the meeting that Barnham Trojans football club wished to replace the old Red Cross hut with a wired compound for their goal store. The council had understood that the hut was to be replaced by something similar, but the club had not submitted any proposals for consideration.

<u>Resolved</u>: Not to permit the erection of a wired compound as a goal store on the old Red Cross hut site nor elsewhere on the playing field. The Clerk to ask Barnham Trojans to submit a proper proposal for consideration.

The Clerk reported that he had received two emails relating to the Landspeed housing survey.

- 1. Mr Clive Butler asked for confirmation that the council supported the survey and that there was no hidden agenda to use the results to support a perceived need for further housing in the village.
- 2. Mr Madeley asked if the council supported the survey.

The council had consulted with ADC on the survey and supported it as the results would assist in the review of the Neighbourhood Plan. Further comment will be reserved for an agenda item at the next meeting.
