#### 10215 Confirmation of the minutes

The minutes of the Planning Committee meeting held on 16<sup>th</sup> December, 2014 were approved and signed by the Chairman.

## 10315 Matters arising

The Chairman allowed Mr. Douglas Briggs (Architect) to speak on the issues the Council sees with the proposed redevelopment of Stafford Cottages. The boundary dispute is a civil matter but can be dealt with by a condition to site the new build no closer than 1 metre to the legally established boundary line. The front elevation will be in line with the front elevation of Fir Trees, the neighbouring property. If the planning application is amended the Committee resolved that there will be no objection.

#### 10415 Public Questions

Mr. E. Camerer-Cass had heard that an objection to the Arun Council proposed development of 2000+ homes in Eastergate/Barnham had been lodged by local Parish Councils including Walberton with Strutt and Parker acting as agents. The Clerk explained that although Walberton were involved through membership of the "Parishes Cluster" this particular initiative was being funded by Eastergate and Barnham Parish Councils and they had asked Mr Paul Collins of Strutt and Parker to prepare a detailed objection to be presented to Arun District Council.
